DID YOU KNOW?

Tacony was not only at the forefront of our country's defense during the Second World War at the Disston Saw Works and Armor Plating Plant. After the War Tacony was literally at the forefront of defending our city just west of the Tacony Palmyra Bridge within Disston Park! In the square bounded by Magee Avenue, the railroad, Levick Street and Keystone Street, an anti-aircraft defense battery consisting of 4 ninety-millimeter guns and 4 small gasoline engine-driven Quad 50 caliber machine guns protected our area from incoming attacks at each corner. The guns were originally wheeled but later were placed in protective sandbag enclosures. The 90 mm guns were located in the block between Magee and Hellerman while the support buildings were situated between Levick and Hellerman. The support buildings included the mess hall, motor pool and armaments buildings. Live ammunition was stored in the sandbagged gun emplacements and bigger quantities in sandbagged bunkers adjacent to the railroad.

It was approximately 1947 when the United States Army fenced off the two-square block area where neighborhood children once roamed freely. Personnel and vehicle entrances were established at the foot of Hellerman Street. Exactly when the installation was removed is uncertain. At the time, Keystone Street had not been paved south of Magee Avenue and did not exist between Robbins and Levick Streets. Tolls on the Tacony-Palmyra Bridge were 5 cents and Levick Street carried two-way traffic to and from the Bridge to Roosevelt Boulevard. From Tacony Town Watch...

We are excited to announce tthat the Philadelphia Police Department rolled out **Police Service Areas** in all police districts beginning January 2010. The City of Philadelphia is now geographically divided into 23 districts, each lead by a police captain. The 15th Police District Captain is Frank Bachmayer. Each district has at least one PSA (Police Service Area) depending on district size; the 15th is divided into 3. Each PSA is headed by a police lieutenant, who along with a team of sergeants and officers is responsible for coordinating police services within their PSA. This is the first step toward establishing accountability for both the police and the community, in the hope of building a proactive neighborhood policing strategy.

The officers assigned to a particular PSA will handle calls for service primarily within their PSA boundaries but they are not exempt from having to cover another area in an emergency. The PSA officers assigned to a particular area are required to spend time getting to know the community within their boundaries, its chronic crime and disorder issues and the community members who live and work there.

Starting January 18, 2010 there were a series of meetings held in all PSA Communities. Tacony held a successful meeting on January 20, 2010 at the Tacony Baptist Church. There will be monthly meetings held in each PSA, coordinated and facilitated through the local town watch organizations. The purpose of these meetings is to build a partnership between police and community that will result in a coordinated response to systemic issues of crime and disorder. Over the next year, the monthly PSA meeting will offer police and community members training in problem-solving.

Residents, town watches, civics, community organizations, churches, schools, businesses and others within a PSA will work with their PSA team to help design and implement problem-solving strategies. We can now create and sustain a vision for building safe and healthy neighborhoods.

The 15th Police District is comprised of 3 PSA's. Tacony is settled between both PSA 2 and PSA 3. Meetings are held separately for each location with two separate Lieutenants and two separate facilitators. PSA 2 covers from Bridge Street North to Knorr Street and PSA 3 covers Knorr Street North to Rhawn Street. But if you are a resident of Tacony you can still contact me as the PSA 3 Facilitator to resolve your problems as both facilitators, sergeants and lieutenants correspond regarding both service locations.

You may ask how you can help. The answer? Get involved! We need a representative from each block in Tacony to communicate with the town watch and the civic association regarding any problems you may be having. Our groups may have a resolution to your problem so that you can enjoy a better quality of life.

Tacony Town Watch, Inc is in need of block watchers and patrolling members, drivers and riders. Tacony Civic is always looking for members for their Quality of Life Committee. Together both of these groups have over 50 years experience dedicated to the residents of Tacony. Together we can make a difference!

Zoning Variances

6414-22 Hegerman Street - permit to construct four (4) attached garages at a vacant site zoned "r-9" Residential. Meeting was held on March 11 to discuss with neighbors and applicant. TCA did not oppose with provisos. ZBA granted variance with provisos on March 24th. Will be discussed at meeting.

7101 Keystone Street - permit for a 2-family dwelling at a mixeduse property zoned "g-2" Industrial. Meeting was held on March 15 to discuss with neighbors and applicant. TCA did not oppose with proviso for owner occupancy only. Awaiting ZBA decision. Will be discussed at meeting.

7109 Keystone Street - permit for a 2-family dwelling at a vacant (shell) property zoned "G-2" Industrial. Meeting was held on March 15 to discuss with neighbors and applicant. TCA opposed after unsuccessfully seeking provisos or compromise on the part of applicant. ZBA granted variance on March 16th. Will be discussed.

6942 Marsden Street - permit for two (2) open air slots at a detached single family residence. TCA did not oppose at ZBA hearing on March 17. ZBA granted variance.

4923 Friendship Street - legalization of automotive repair shop with no body or fender work and no spray painting. TCA did not oppose at hearing on April 13. ZBA granted variance. Will be discussed.

6425 New State Road - legalization of wireless service antennas on wood pole 86 feet in height, plus existing fenced area to house equipment. A meeting was held at the site on April 9 and the TCA did not oppose at the ZBA hearing on April 14. ZBA granted variance. Will be discussed.

6382 Marsden Street - permit to use first floor rear as real estate management office. Meeting was held at the property on April 13 to discuss with neighbors and applicant. TCA did not oppose with provisos. ZBA granted variance with provisos on April 15.

4117 Tyson Avenue - legalization of a three-family dwelling at a property constructed as a 2-family dwelling. Meeting with neighbors and applicant scheduled for May 4th at Disston Recreation Center. Will be discussed at meeting.

DISSTON PARK FOCUS OF MANY COMMUNITY EVENTS

This year the spotlight is shining on Disston Park like never before! On April 24th, over 300 volunteers from the community and **Comcast** came to the Park as part of *Comcast Cares Day*, an annual day of service sponsored by the local cable giant. It was part of a two-pronged effort that also included improvements at Pennypack on the Delaware. About 25 new trees were planted in the Park near Unruh Avenue, clean-up was performed, benches and fences painted and the new *Good Food Community Garden* was installed near Magee Avenue. Created through a unique partnership of the **Food Network, Tacony Civic Association, Comcast** and the **Delaware River City Corporation**, the herbs and vegetables from the garden will benefit local organizations for free distribution. On hand were all of our local political representatives as well as **Comcast** President Brian Roberts to offer encouraging words to the many Tacony residents and **Comcast** employees gathered at Disston Park.

May 8th will be the annual TCA clean-up of Disston Park and vicinity, with a focus on the areas from Longshore to Princeton Avenues. The clean-up will begin at 9 AM and conclude by 12 PM. Later this summer... watch for the groundbreaking at Disston Park for the new Engine 38 facility near the corner of Magee Avenue.
