DID YOU KNOW?

As Tacony gears up for construction of its third new firehouse building in its storied history, did you know that right here in Philadelphia Benjamin Franklin helped organize the first volunteer fire company in 1736? Known as the Union Fire Company, each member would provide six leather buckets and two linen bags which were brought to all fires. The buckets would carry water to put out the flames and the bags would store any salvaged valuable personal property. Other early firefighting organizations in Philadelphia included Fellowship Fire Company and Hand-in-Hand Fire Company, which worked along with Union Fire Company to purchase a fire bell in 1752 to be installed on Fourth Street. Volunteer fire units served the city until 1871, after a City Council ordinance declared that the growing city needed a municipal fire department. Competition between fire companies had grown counterproductive as neighborhood fire companies became increasingly affiliated with political machines.



One of the hallmarks of the early days of firefighting were cast iron "fire marks," which were plaques typically affixed at the front of the home to denote whether it was covered by fire insurance. While British fire marks were utilized to identify the affiliated fire company located closest to the blaze, in the United States these plaques

served as a guarantee that the affiliated insurance company would reward the fire company responsible for extinguishing the fire. In addition, the fire marks were intended to discourage malicious arson by displaying that the owner of the property was insured.

After the establishment of the Philadelphia Fire Department in 1871, the marks lost their usefulness; however many insurance companies continued to produce them for advertising purposes. Typically depicting a gilded image of a hydrant emitting a stream of gushing water, or the logo of the associated insurance company, the plaques usually took the form of an oval or shield. Many can still be found adorning the fronts of older homes in neighborhoods across the city.

Zoning Variances

6801 New State Road - legalization of three (3) separate uses including dismantling of automobiles for export and creation of five (5) loading spaces and legalization of 6 foot fencing at a multi-tenant industrial building. Original hearing date was June 9. TCA did not oppose to a 3-year temporary variance, which was granted by ZBA. Will be discussed at meeting.

4201 Princeton Avenue - variance for creation of an outdoor play area and 6 foot high wrought iron fencing to surround the yard area at St. Stephen's United Church of Christ. Hearing occurred on June 15. TCA did not oppose and ZBA granted variance. Will be discussed at meeting.

4732 Rawle St. - variance to erect a 25' x 23'4" garage of concrete block construction to replace an older smaller garage of metal construction. Hearing was held on August 3. TCA did not oppose but requested several provisos including brick facade. ZBA still pending in its decision. Will be discussed at meeting.

7044 Torresdale Ave. - legalization of doctor's office with "non-incidental" living quarters above. Zoned R-5, the original variance was in place

only with doctor's office and doctor's residence above. Use of second floor is proposed for nondoctor occupancy. TCA did not oppose and ZBA granted variance from hearing on August 4.

7355 Melrose Street - worked in conjunction with Holmesburg Civic Association (HCA). Legalization of body and fender work in a one story automotive garage building. TCA and HCA did not oppose and ZBA granted variance on August 10.

6810 Frankford Ave. - working in conjunction with Mayfair Civic Association (MCA). Variance for a restaurant/bar on the first and second floor with accessory office/storage area on third floor at a building converted to office use approximately 8 years ago. Rescheduled hearing held on September 1. TCA is supporting MCA in its opposition to this variance. Will be discussed at meeting.

6369 Edmund St. - legalization of a three-family dwelling in a two-story row style property constructed as a two-family dwelling. Community meeting will be held prior to General Meeting on September 14. Will be discussed at meeting. ZBA hearing to be held on September 21.
